Guest Liability Waiver & Release Agreement

PLEASE READ CAREFULLY BEFORE SIGNING

By entering Paradise Cat Cafe (the “Premises”) and participating in activities that include being around or interacting with cats (the “Activities”), I acknowledge and agree to the following terms. This agreement is made on behalf of myself and, if applicable, any minors in my care.

1. Assumption of Risk

I understand that interacting with cats, while generally safe, comes with inherent and unpredictable risks. These may include—but are not limited to—scratches, bites, allergic reactions, infections (such as ringworm), or exposure to animal waste. I acknowledge that cats may react unexpectedly, even when properly socialized. I am voluntarily participating in the Activities with full awareness of the risks, and I accept personal responsibility for any physical, emotional, or property-related injury or damage.

2. Release of Liability

I, on behalf of myself, my heirs, legal representatives, and assigns, hereby release and discharge Paradise Cat Cafe, LLC, its owners, staff, volunteers, affiliates, partner rescues/shelters, contractors, and agents from any and all claims or liabilities, whether caused by negligence or otherwise, arising out of or relating to my presence on the Premises or participation in Activities. This includes, without limitation, claims for personal injury, illness, property damage, emotional distress, or death.

3. Indemnification

I agree to indemnify and hold harmless Paradise Cat Cafe, LLC and all associated persons and entities from any claims, actions, or expenses (including attorney’s fees) that may arise due to my own actions, omissions, or conduct during my visit. If I cause damage to the facility, animals, or property through negligence or intentional behavior, I agree to be financially responsible for the costs of repairs or replacements.

4. Policies & Conduct

I agree to follow all posted rules and verbal instructions from staff. I understand that rough handling of cats, feeding without permission, or behavior that disrupts the animals or other guests may result in immediate removal from the premises without refund. All minors (under the age of 18) must be accompanied by a parent or legal guardian while on the premises.

5. Medical Responsibility

I understand that Paradise Cat Cafe does not provide medical insurance for guests. I am solely responsible for any medical expenses incurred as a result of injuries or incidents during my visit. I affirm that I am physically capable of safely participating in the Activities and that I do not have allergies or conditions that would be aggravated by exposure to cats.

I understand that this release extends to unknown claims and is intended to be as broad and inclusive as the law allows.
